# Large scale behavior of wavelet coefficients of non-linear subordinated processes with long memory

#### Abstract

We study the asymptotic behavior of wavelet coefficients of random processes with long memory. These processes may be stationary or not and are obtained as the output of non-linear filter with Gaussian input. The wavelet coefficients that appear in the limit are random, typically non-Gaussian and belong to a Wiener chaos. They can be interpreted as wavelet coefficients of a generalized self-similar process.

## 1. Introduction

Let $X=\left\{X_{n}\right\}_{n \in \mathbb{Z}}$ be a stationary Gaussian process with mean zero, unit variance and spectral density $f(\lambda), \lambda \in(-\pi, \pi]$ and thus covariance equal to

$$
r(n)=\mathbb{E}\left(X_{0} X_{n}\right)=\int_{-\pi}^{\pi} \mathrm{e}^{\mathrm{i} n \lambda} f(\lambda) \mathrm{d} \lambda .
$$

The process $\left\{X_{n}\right\}_{n \in \mathbb{Z}}$ is said to have short memory or short-range dependence if $f(\lambda)$ is bounded around $\lambda=0$ and long memory or long-range dependence if $f(\lambda) \rightarrow \infty$ as $\lambda \rightarrow 0$. We will suppose that $\left\{X_{n}\right\}_{n \in \mathbb{Z}}$ has long-memory with memory parameter $d>0$, that is,

$$
f(\lambda) \sim|\lambda|^{-2 d} f^{*}(\lambda) \text { as } \lambda \rightarrow 0
$$

[^0]where $f^{*}(\lambda)$ is a bounded spectral density which is continuous and positive at the origin. It is convenient to interpret this behavior as the result of a fractional integrating operation, whose transfer function reads $\lambda \mapsto\left(1-\mathrm{e}^{-\mathrm{i} \lambda}\right)^{-d}$. Hence we set
\[

$$
\begin{equation*}
f(\lambda)=\left|1-\mathrm{e}^{-\mathrm{i} \lambda}\right|^{-2 d} f^{*}(\lambda), \quad \lambda \in(-\pi, \pi] . \tag{1}
\end{equation*}
$$

\]

We relax the above assumptions in two ways :

1. Consider, instead of the Gaussian process $\left\{X_{n}\right\}_{n \in \mathbb{Z}}$ the non-Gaussian process $\left\{G\left(X_{n}\right)\right\}_{n \in \mathbb{Z}}$ where $G$ is a non-linear filter such that $\mathbb{E}\left[G\left(X_{n}\right)\right]=0$ and $\mathbb{E}\left[G\left(X_{n}\right)^{2}\right]<\infty$. The non-linear process $\left\{G\left(X_{n}\right)\right\}_{n \in \mathbb{Z}}$ is said to be subordinated to the Gaussian process $\left\{X_{n}\right\}_{n \in \mathbb{Z}}$.
2. Drop the stationarity assumption by considering a process $\left\{Y_{n}\right\}_{n \in \mathbb{Z}}$ which becomes stationary when differenced $K \geq 0$ times.

We shall thus consider $\left\{Y_{n}\right\}_{n \in \mathbb{Z}}$ such that

$$
\left(\Delta^{K} Y\right)_{n}=G\left(X_{n}\right), \quad n \in \mathbb{Z}
$$

where $(\Delta Y)_{n}=Y_{n}-Y_{n-1}$ and where $\left\{X_{n}\right\}_{n \in \mathbb{Z}}$ is Gaussian with spectral density $f$ satisfying (1).

Since $Y=\left\{Y_{n}\right\}_{n \in \mathbb{Z}}$ is random so will be its wavelet coefficients $\left\{W_{j, k}, j \geq 0, k \in \mathbb{Z}\right\}$ which are defined below. Our goal is to find the distribution of the wavelet coefficients at large scales $j \rightarrow \infty$. This is an important step in developing methods for estimating the underlying long memory parameter $d$. The large scale behavior of the wavelet coefficients was studied in [1] in the case where there was no filter $G$, that is, when $Y$ is a Gaussian process such that $\Delta^{K} Y=X$, and also in the case where $Y$ is a non-Gaussian linear process (see [2]).

We obtain our random wavelet coefficients by using more general linear filters that those related to multiresolution analysis (MRA) (see for e.g. [3], [4]). In practice, however, the methods are best implemented using Mallat's algorithm and a MRA. Our filters are denoted $h_{j}$ where $j$ is the scale and we use a scaling factor $\gamma_{j} \uparrow \infty$ as $j \uparrow \infty$. In the case of a MRA, $\gamma_{j}=2^{j}$ and $h_{j}$ are generated by a (low pass) scaling filter and its corresponding quadratic (high pass) mirror filter. More generally one can use a scaling function $\varphi$ and a mother wavelet $\psi$ to generate the random wavelet coefficients by setting

$$
\begin{equation*}
W_{j, k}=\int_{\mathbb{R}} \psi_{j, k}(t)\left(\sum_{\ell \in \mathbb{Z}} \varphi(t-\ell) Y_{\ell}\right) \mathrm{d} t \tag{2}
\end{equation*}
$$

where $\psi_{j, k}=2^{-j / 2} \psi\left(2^{-j} t-k\right), j \geq 0$. Observe that we use here the engineering convention that large values of $j$ correspond to large scales and hence low frequencies. If $\varphi$ and $\psi$ have compact support then the corresponding filters $h_{j}$ have finite support of size $O\left(2^{j}\right)$. For more details on related conditions on $\varphi$ and $\psi$ (see [1]).

The idea of using wavelets to estimate the long memory coefficient $d$ goes back to Wornell and al. ([5]) and Flandrin ([6, 7, 8, 9]). See also Abry and al. ([10, 11]). Those methods are an alternative to the Fourier methods developed by Fox and Taqqu ([12]) and Robinson ( $[13,14]$. For a general comparison of Fourier and wavelet approach, see [15]. The case of the Rosenblatt process, which is the Hermite process of order $q=2$, was studied by [16].

The paper is structured as follows. In Section 2, we introduce the wavelet filters. The processes are defined in Section 3 using integral representations and Section 4 presents the so-called Wiener chaos decomposition. The main result and its interpretations is given in Section 5. It is proved in Section 6. Auxiliary lemmas are presented and proved in Sections 7 and 8 .

## 2. Assumptions on the wavelet filter

The wavelet transform of $Y$ involves the application of a linear filter $h_{j}(\tau), \tau \in \mathbb{Z}$, at each scale $j \geq 0$. We shall characterize the filters $h_{j}$ by their discrete Fourier transform :

$$
\widehat{h}_{j}(\lambda)=\sum_{\tau \in \mathbb{Z}} h_{j}(\tau) \mathrm{e}^{-\mathrm{i} \lambda \tau}, \lambda \in[-\pi, \pi] .
$$

Assumptions on $\widehat{h}_{j}$ are stated below. The resulting wavelet coefficients are defined as

$$
W_{j, k}=\sum_{\ell \in \mathbb{Z}} h_{j}\left(\gamma_{j} k-\ell\right) Y_{\ell}, \quad j \geq 0, k \in \mathbb{Z},
$$

where $\gamma_{j} \uparrow \infty$ is a sequence of non-negative scale factors applied at scale $j$, for example $\gamma_{j}=2^{j}$. We will assume that for any $m \in \mathbb{Z}$,

$$
\begin{equation*}
\lim _{j \rightarrow \infty} \frac{\gamma_{j+m}}{\gamma_{j}}=\bar{\gamma}_{m}>0 \tag{3}
\end{equation*}
$$

As noted, in this paper, we do not assume that the wavelet coefficients are orthogonal nor that they are generated by a multiresolution analysis. Our assumptions on the filters $h_{j}$ are as follows:
a. Finite support: For each $j,\left\{h_{j}(\tau)\right\}_{\tau \in \mathbb{Z}}$ has finite support.
b. Uniform smoothness: There exists $M \geq K, \alpha>1 / 2$ and $C>0$ such that for all $j \geq 0$ and $\lambda \in[-\pi, \pi]$,

$$
\begin{equation*}
\left|\widehat{h}_{j}(\lambda)\right| \leq \frac{C \gamma_{j}^{1 / 2}\left|\gamma_{j} \lambda\right|^{M}}{\left(1+\gamma_{j}|\lambda|\right)^{M+\alpha}} \tag{4}
\end{equation*}
$$

By $2 \pi$-periodicity of $\widehat{h}_{j}$ this inequality can be extended to $\lambda \in \mathbb{R}$ as

$$
\begin{equation*}
\left|\widehat{h}_{j}(\lambda)\right| \leq C \frac{\gamma_{j}^{1 / 2}\left|\gamma_{j}\{\lambda\}\right|^{M}}{\left(1+\gamma_{j}|\{\lambda\}|\right)^{\alpha+M}} \tag{5}
\end{equation*}
$$

where $\{\lambda\}$ denotes the element of $(-\pi, \pi]$ such that $\lambda-\{\lambda\} \in 2 \pi \mathbb{Z}$.
c. Asymptotic behavior: There exists some non identically zero function $\widehat{h}_{\infty}$ such that for any $\lambda \in \mathbb{R}$,

$$
\begin{equation*}
\lim _{j \rightarrow+\infty}\left(\gamma_{j}^{-1 / 2} \widehat{h}_{j}\left(\gamma_{j}^{-1} \lambda\right)\right)=\widehat{h}_{\infty}(\lambda) \tag{6}
\end{equation*}
$$

Observe that while $\widehat{h}_{j}$ is $2 \pi$-periodic, the function $\widehat{h}_{\infty}$ is a non-periodic function on $\mathbb{R}$ (this follows from (12) below). For the connection between these assumptions on $h_{j}$ and corresponding assumptions on the scaling function $\varphi$ and the mother wavelet $\psi$ in the classical wavelet setting (2) (see [1]). In particular, in that case, one has $\widehat{h}_{\infty}=\widehat{\varphi}(0) \widehat{\psi}$.

Our goal is to study the large scale behavior of the random wavelet coefficients

$$
\begin{equation*}
W_{j, k}=\sum_{\ell \in \mathbb{Z}} h_{j}\left(\gamma_{j} k-\ell\right) Y_{\ell}=\sum_{\ell \in \mathbb{Z}} h_{j}\left(\gamma_{j} k-\ell\right)\left(\Delta^{-K} G(X)\right)_{\ell}, \tag{7}
\end{equation*}
$$

where we set symbolically $Y_{\ell}=\left(\Delta^{-K} G(X)\right)_{\ell}$ for $\left(\Delta^{K} Y\right)_{\ell}=G\left(X_{\ell}\right)$.
By Assumption (4), $h_{j}$ has null moments up to order $M-1$, that is, for any $m \in$ $\{0, \cdots, M-1\}$,

$$
\begin{equation*}
\sum_{\ell \in \mathbb{Z}} h_{j}(\ell) \ell^{m}=0 . \tag{8}
\end{equation*}
$$

Therefore, since $M \geq K, \widehat{h}_{j}$ can be expressed as

$$
\begin{equation*}
\widehat{h}_{j}(\lambda)=\left(1-\mathrm{e}^{-\mathrm{i} \lambda}\right)^{K} \widehat{h}_{j}^{(K)}(\lambda), \tag{9}
\end{equation*}
$$

where $\widehat{h}_{j}^{(K)}$ is also a trigonometric polynomial of the form

$$
\begin{equation*}
\widehat{h}_{j}^{(K)}(\lambda)=\sum_{\tau \in \mathbb{Z}} h_{j}^{(K)}(\tau) \mathrm{e}^{-\mathrm{i} \lambda \tau} \tag{10}
\end{equation*}
$$

since $h_{j}^{(K)}$ has finite support for any $j$. Then we obtain another way of expressing $W_{j, k}$, namely,

$$
\begin{equation*}
W_{j, k}=\sum_{\ell \in \mathbb{Z}} h_{j}^{(K)}\left(\gamma_{j} k-\ell\right) G\left(X_{\ell}\right) \tag{11}
\end{equation*}
$$

We have thus incorporated the linear filter $\Delta^{-K}$ in (7) into the filter $h_{j}$ and denoted the new filter $h_{j}^{(K)}$.

## Remarks

1. Since $\left\{G\left(X_{\ell}\right), \ell \in \mathbb{Z}\right\}$ is stationary, it follows from (11) that $\left\{W_{j, k}, k \in \mathbb{Z}\right\}$ is stationary for each scale $j$.
2. Observe that $\Delta^{K} Y$ is centered by definition. However, by (8), the definition of $W_{j, k}$ only depends on $\Delta^{M} Y$. In particular, provided that $M \geq K+1$, its value is not modified if a constant is added to $\Delta^{K} Y$, whenever $M \geq K+1$.
3. Assumptions (4) and (6) imply that for any $\lambda \in \mathbb{R}$,

$$
\begin{equation*}
\left|\widehat{h}_{\infty}(\lambda)\right| \leq C \frac{|\lambda|^{M}}{(1+|\lambda|)^{\alpha+M}} \tag{12}
\end{equation*}
$$

Hence $\widehat{h}_{\infty} \in L^{2}(\mathbb{R})$ since $\alpha>1 / 2$.
4. The Fourier transform of $f$,

$$
\begin{equation*}
\mathfrak{F}(f)(\xi)=\int_{\mathbb{R}^{q}} f(t) \mathrm{e}^{-\mathrm{i} t^{T} \xi} \mathrm{~d}^{q} t, \quad \xi \in \mathbb{R}^{q} \tag{13}
\end{equation*}
$$

is defined for any $f \in L^{2}\left(\mathbb{R}^{q}, \mathbb{C}\right)$. We let $h_{\infty}$ be the $L^{2}(\mathbb{R})$ function such that $\widehat{h}_{\infty}=$ $\mathfrak{F}\left[h_{\infty}\right]$.

## 3. Integral representations

It is convenient to use an integral representation in the spectral domain to represent the random processes (see for example [17, 18]). The stationary Gaussian process $\left\{X_{k}, k \in \mathbb{Z}\right\}$ with spectral density (1) can be written as

$$
\begin{equation*}
X_{\ell}=\int_{-\pi}^{\pi} \mathrm{e}^{\mathrm{i} \lambda \ell} f^{1 / 2}(\lambda) \mathrm{d} \widehat{W}(\lambda)=\int_{-\pi}^{\pi} \frac{\mathrm{e}^{\mathrm{i} \lambda \ell} f^{* 1 / 2}(\lambda)}{\mid 1-\mathrm{e}^{-\mathrm{i} \lambda \mid d}} \mathrm{~d} \widehat{W}(\lambda), \quad \ell \in \mathbb{N} \tag{14}
\end{equation*}
$$

This is a special case of

$$
\begin{equation*}
\widehat{I}(g)=\int_{\mathbb{R}} g(x) \mathrm{d} \widehat{W}(x) \tag{15}
\end{equation*}
$$

where $\widehat{W}(\cdot)$ is a complex-valued Gaussian random measure satisfying

$$
\begin{align*}
\mathbb{E}(\widehat{W}(A)) & =0 \quad \text { for every Borel set } A \text { in } \mathbb{R}  \tag{16}\\
\mathbb{E}(\widehat{W}(A) \widehat{\widehat{W}}(B)) & =|A \cap B| \text { for every Borel sets } A \text { and } B \text { in } \mathbb{R}  \tag{17}\\
\sum_{j=1}^{n} \widehat{W}\left(A_{j}\right) & =\widehat{W}\left(\bigcup_{j=1}^{n} A_{j}\right) \text { if } A_{1}, \cdots, A_{n} \text { are disjoint Borel sets in } \mathbb{R},  \tag{18}\\
\widehat{W}(A) & =\frac{\widehat{W}(-A)}{} \quad \text { for every Borel set } A \text { in } \mathbb{R} . \tag{19}
\end{align*}
$$

The integral (15) is defined for any function $g \in L^{2}(\mathbb{R})$ and one has the isometry

$$
\mathbb{E}\left(|\widehat{I}(g)|^{2}\right)=\int_{\mathbb{R}}|g(x)|^{2} \mathrm{~d} x
$$

The integral $\widehat{I}(g)$, moreover, is real-valued if

$$
g(x)=\overline{g(-x)}
$$

We shall also consider multiple Itô-Wiener integrals

$$
\widehat{I}_{q}(g)=\int_{\mathbb{R}^{q}}^{\prime \prime} g\left(\lambda_{1}, \cdots, \lambda_{q}\right) \widehat{\mathrm{d}}\left(\lambda_{1}\right) \cdots \mathrm{d} \widehat{W}\left(\lambda_{q}\right)
$$

where the double prime indicates that one does not integrate on hyperdiagonals $\lambda_{i}=$ $\pm \lambda_{j}, i \neq j$. The integrals $\widehat{I}_{q}(g)$ are handy because we will be able to expand our non-linear functions $G\left(X_{k}\right)$ introduced in Section 1 in multiple integrals of this type.

These multiples integrals are defined as follows. Denote by $\overline{L^{2}}\left(\mathbb{R}^{q}, \mathbb{C}\right)$ the space of complex valued functions defined on $\mathbb{R}^{q}$ satisfying

$$
\begin{gather*}
g\left(-x_{1}, \cdots,-x_{q}\right)=\overline{g\left(x_{1}, \cdots, x_{q}\right)} \text { for }\left(x_{1}, \cdots, x_{q}\right) \in \mathbb{R}^{q},  \tag{20}\\
\|g\|_{L^{2}}^{2}:=\int_{\mathbb{R}^{q}}\left|g\left(x_{1}, \cdots, x_{q}\right)\right|^{2} \mathrm{~d} x_{1} \cdots \mathrm{~d} x_{q}<\infty . \tag{21}
\end{gather*}
$$

Let $\tilde{L}^{2}\left(\mathbb{R}^{q}, \mathbb{C}\right)$ denote the set of functions in $\overline{L^{2}}\left(\mathbb{R}^{q}, \mathbb{C}\right)$ that are symmetric in the sense that $g=\tilde{g}$ where $\tilde{g}\left(x_{1}, \cdots, x_{q}\right)=1 / q!\sum_{\sigma} g\left(x_{\sigma(1)}, \cdots, x_{\sigma(q)}\right)$, where the sum is over all permutations of $\{1, \ldots, q\}$. One defines now the multiple integral with respect to the spectral measure $\widehat{W}$ by a density argument. For a step function of the form

$$
g=\sum_{j_{\ell}= \pm 1, \cdots, \pm N} c_{j_{1}, \cdots, j_{n}} 1_{\Delta_{j_{1}}} \times \cdots \times 1_{\Delta_{j_{n}}}
$$

where the $c$ 's are real-valued, $\Delta_{j_{\ell}}=-\Delta_{-j_{\ell}}$ and $\Delta_{j_{\ell}} \cap \Delta_{j_{m}}=\emptyset$ if $\ell \neq m$, one sets

$$
\begin{equation*}
\widehat{I}_{q}(g)=\sum_{j_{\ell}= \pm 1, \cdots, \pm N}^{\prime \prime} c_{j_{1}, \cdots, j_{n}} \widehat{W}\left(\Delta_{j_{1}}\right) \cdots \widehat{W}\left(\Delta_{j_{n}}\right) . \tag{22}
\end{equation*}
$$

Here, $\sum^{\prime \prime}$ indicates that one does not sum over the hyperdiagonals, that is, when $j_{\ell}= \pm j_{m}$ for $\ell \neq m$. The integral $\widehat{I}_{q}$ verifies that

$$
\mathbb{E}\left(\widehat{I}_{q}\left(g_{1}\right) \widehat{I}_{q^{\prime}}\left(g_{2}\right)\right)=\left\{\begin{array}{l}
q!\left\langle g_{1}, g_{2}\right\rangle_{L^{2}}, \text { if } q=q^{\prime}  \tag{23}\\
0, \text { if } q \neq q^{\prime} .
\end{array}\right.
$$

Observe, moreover, that for every step function $g$ with $q$ variables as above

$$
\widehat{I}_{q}(g)=\widehat{I}_{q}(\tilde{g}) .
$$

Since the set of step functions is dense in $\overline{L^{2}}\left(\mathbb{R}^{q}, \mathbb{C}\right)$, one can extend $\widehat{I}_{q}$ to an isometry from $\overline{L^{2}}\left(\mathbb{R}^{q}, \mathbb{C}\right)$ to $L^{2}(\Omega)$ and the above properties hold true for this extension.

Remark. Property (20) of the function $f$ in $\overline{L^{2}}\left(\mathbb{R}^{q}, \mathbb{C}\right)$ together with Property (19) of $\widehat{W}$ ensure that $\widehat{I}_{q}(f)$ is a real-valued random variable.

## 4. Wiener Chaos

Our results are based on the expansion of the function $G$, introduced in Section 11 in Hermite polynomials. The Hermite polynomials are

$$
H_{q}(x)=(-1)^{q} e^{\frac{x^{2}}{2}} \frac{d^{q}}{d x^{q}}\left(e^{-\frac{x^{2}}{2}}\right),
$$

in particular, $H_{0}(x)=1, H_{1}(x)=x, H_{2}(x)=x^{2}-1$. If $X$ is a normal random variable with mean 0 and variance 1 , then

$$
\mathbb{E}\left(H_{q}(X) H_{q^{\prime}}(X)\right)=\int_{\mathbb{R}} H_{q}(x) H_{q^{\prime}}(x) \frac{1}{\sqrt{2 \pi}} \mathrm{e}^{-x^{2} / 2} \mathrm{~d} x=q!\delta_{q, q^{\prime}}
$$

Moreover,

$$
\begin{equation*}
G(X)=\sum_{q=1}^{+\infty} \frac{c_{q}}{q!} H_{q}(X) \tag{24}
\end{equation*}
$$

where the convergence is in $L^{2}(\Omega)$ and where

$$
\begin{equation*}
c_{q}=\mathbb{E}\left(G(X) H_{q}(X)\right) \tag{25}
\end{equation*}
$$

The expansion (24) is called a Wiener chaos expansion with each term in the chaos expansion living in a different chaos. The expansion (24) starts at $q=1$, since

$$
c_{0}=\mathbb{E}\left(G(X) H_{0}(X)\right)=\mathbb{E}(G(X))=0
$$

by assumption. The condition $\mathbb{E}\left(G(X)^{2}\right)<\infty$ implies

$$
\begin{equation*}
\sum_{q=1}^{+\infty} \frac{c_{q}^{2}}{q!}<\infty \tag{26}
\end{equation*}
$$

Hermite polynomials are related to multiple integrals as follows: if $X=\int_{\mathbb{R}} g(x) \mathrm{d} \widehat{W}(x)$ with $\mathbb{E}\left(X^{2}\right)=\int_{\mathbb{R}}|g(x)|^{2} \mathrm{~d} x=1$ and $g(x)=\overline{g(-x)}$ so that $X$ has unit variance and is real-valued, then

$$
\begin{equation*}
H_{q}(X)=\widehat{I}_{q}\left(g^{\otimes q}\right)=\int_{\mathbb{R}^{q}}^{\prime \prime} g\left(x_{1}\right) \cdots g\left(x_{q}\right) \mathrm{d} \widehat{W}\left(x_{1}\right) \cdots \mathrm{d} \widehat{W}\left(x_{q}\right) . \tag{27}
\end{equation*}
$$

The expansion (24) of $G$ induces a corresponding expansion of the wavelet coefficients $W_{j, k}$, namely,

$$
\begin{equation*}
W_{j, k}=\sum_{q=1}^{+\infty} \frac{c_{q}}{q!} W_{j, k}^{(q)} \tag{28}
\end{equation*}
$$

where by (11) one has

$$
\begin{equation*}
W_{j, k}^{(q)}=\sum_{\ell \in \mathbb{Z}} h_{j}^{(K)}\left(\gamma_{j} k-\ell\right) H_{q}\left(X_{\ell}\right) . \tag{29}
\end{equation*}
$$

The Gaussian sequence $\left\{X_{n}\right\}_{n \in \mathbb{Z}}$ is long-range dependent because its spectrum at low frequencies behaves like $|\lambda|^{-2 d}$ with $d>0$ and hence explodes at $\lambda=0$. What about the processes $\left\{H_{q}\left(X_{\ell}\right)\right\}_{\ell}$ for $q \geq 2$ ? What is the behavior of the spectrum at low frequencies? Does it explodes at $\lambda=0$ ? The answer depends on the respective values of $q$ and $d$. Let us define

$$
\begin{equation*}
q_{c}=\max \{q \in \mathbb{N}: q<1 /(1-2 d)\} \tag{30}
\end{equation*}
$$

and

$$
\begin{equation*}
d(q)=q d+(1-q) / 2 . \tag{31}
\end{equation*}
$$

One has

$$
\begin{equation*}
d(q)>0 \quad \text { if } q \leq q_{c}, \quad \text { that is if } q<1 /(1-2 d) \tag{32}
\end{equation*}
$$

The following result shows that the spectral density of $\left\{H_{q}\left(X_{\ell}\right)\right\}_{\ell \in \mathbb{Z}}$ has a different behavior at zero frequency depending on whether $q \leq q_{c}$ or $q>q_{c}$. It is long-range dependent when $q \leq q_{c}$ and short-range dependent when $q>q_{c}$. We first give a definition.

Definition 4.1. The convolution of two locally integrable ( $2 \pi$ )-periodic functions $g_{1}$ and $g_{2}$ is defined as

$$
\begin{equation*}
\left(g_{1} \star g_{2}\right)(\lambda)=\int_{-\pi}^{\pi} g_{1}(u) g_{2}(\lambda-u) \mathrm{d} u \tag{33}
\end{equation*}
$$

Moreover the $q$ times self-convolution of $g$ is denoted by $g^{(\star q)}$.
Lemma 4.1. Let $q$ be a positive integer. The spectral density of $\left\{H_{q}\left(X_{\ell}\right)\right\}_{\ell \in \mathbb{Z}}$ is

$$
q!f^{(\star q)}=q!(f \star \cdots \star f)
$$

where the spectral density $f$ of $\left\{X_{\ell}\right\}_{\ell \in \mathbb{Z}}$ is given in (11). Moreover the following holds:
(i) If $q \leq q_{c}$, then $\lambda^{2 d(q)} f^{(\star q)}(\lambda)$ is bounded on $\lambda \in(0, \pi)$ and converges to a positive number as $\lambda \downarrow 0$.
(ii) If $q>q_{c}$, then $f^{(* q)}(\lambda)$ is bounded on $\lambda \in(0, \pi)$ and converges to a positive number as $\lambda \downarrow 0$.

Hence if $q \leq q_{c},\left\{H_{q}\left(X_{\ell}\right)\right\}_{\ell}$ has long memory with parameter $d(q)>0$ whereas if $q>q_{c}$, $\left\{H_{q}(X)\right\}_{\ell}$ has a short-memory behavior.

Proof. By definition of $H_{q}$ and since $X$ has unit variance by assumption, we have

$$
\mathbb{E}\left(H_{q}\left(X_{\ell}\right) H_{q}\left(X_{\ell+m}\right)\right)=q!\left(\int_{-\pi}^{\pi} f(\lambda) \mathrm{e}^{\mathrm{i} \lambda m} \mathrm{~d} \lambda\right)^{q}
$$

Using the fact that, for any two locally integrable ( $2 \pi$ )-periodic functions $g_{1}$ and $g_{2}$, one has

$$
\int_{-\pi}^{\pi}\left(g_{1} \star g_{2}\right)(\lambda) \mathrm{e}^{\mathrm{i} \lambda m} \mathrm{~d} \lambda=\int_{-\pi}^{\pi} g_{1}(u) \mathrm{e}^{\mathrm{i} u m} \mathrm{~d} u \times \int_{-\pi}^{\pi} g_{2}(v) \mathrm{e}^{\mathrm{i} v m} \mathrm{~d} v
$$

we obtain that the spectral density of $\left\{H_{q}\left(X_{\ell}\right)\right\}_{\ell}$ is $q!f^{(* q)}$.
The properties of $f^{(\star q)}$ stated in Lemma 4.1] are proved by induction on $q$ using Lemma8.2. Observe indeed that if $\beta_{1}=d(q)$ and $\beta_{2}=2 d$, then
$\beta_{1}+\beta_{2}-1=2 d(q)+2 d-1=(2 d q+1-q)+2 d-1=2(q+1) d-(q+1)+1=2 d(q+1)$.

Now, consider the expansion of $\Delta^{K} Y_{\ell}=G\left(X_{\ell}\right)=\sum_{q=q_{0}}^{+\infty}\left(c_{q} / q!\right) H_{q}\left(X_{\ell}\right)$, where

$$
\begin{equation*}
q_{0}=\min \left\{q \geq 1, c_{q} \neq 0\right\} \tag{34}
\end{equation*}
$$

The exponent $q_{0}$ is called the Hermite rank of $\Delta^{K} Y$.
In the following, we always assume that at least one summand of $\Delta^{K} Y_{\ell}$ has long memory, that is, in view of Lemma 4.1.

$$
\begin{equation*}
q_{0} \leq q_{c} . \tag{35}
\end{equation*}
$$

## 5. The result and its interpretations

In this section we describe the limit in distribution of the wavelet coefficients $\left\{W_{j+m, k}\right\}_{m, k}$ as $j \rightarrow \infty$, adequately normalized, and we interpret the limit. Recall that $W_{j+m, k}$ involves a sum of chaoses of all order. In the limit, however, only the order $q_{0}$ will prevail. The convergence of finite-dimensional distributions is denoted by $\xrightarrow{\text { fidi }}$.

Theorem 5.1. As $j \rightarrow \infty$, we have

$$
\begin{equation*}
\left\{\gamma_{j}^{-\left(d\left(q_{0}\right)+K\right)} W_{j+m, k}, m, k \in \mathbb{Z}\right\} \xrightarrow{\text { fddi }} c_{q_{0}}\left(f^{*}(0)\right)^{q_{0} / 2}\left\{Y_{m, k}^{\left(q_{0}, K\right)}, m, k \in \mathbb{Z}\right\}, \tag{36}
\end{equation*}
$$

where for every positive integer $q$,

$$
\begin{equation*}
Y_{m, k}^{(q, K)}=\left(\bar{\gamma}_{m}\right)^{1 / 2} \int_{\mathbb{R}^{q}}^{\prime \prime} \frac{\mathrm{e}^{\mathrm{i} k \bar{\gamma}_{m}\left(\zeta_{1}+\cdots+\zeta_{q}\right)}}{\left.\mathrm{i}\left(\zeta_{1}+\cdots+\zeta_{q}\right)\right)^{K}} \frac{\widehat{h}_{\infty}\left(\bar{\gamma}_{m}\left(\zeta_{1}+\cdots+\zeta_{q}\right)\right)}{\left|\zeta_{1}\right|^{d} \cdots\left|\zeta_{q}\right|^{d}} \mathrm{~d} \widehat{W}\left(\zeta_{1}\right) \cdots \mathrm{d} \widehat{W}\left(\zeta_{q}\right) . \tag{37}
\end{equation*}
$$

This Theorem is proved in Section 6.

## Interpretation of the limit.

The limit distribution can be interpreted as the wavelet coefficients of a generalized Hermite process defined below, based on the wavelet family

$$
\begin{equation*}
\left\{h_{\infty, m, k}(t)=\bar{\gamma}_{m}^{-1 / 2} h_{\infty}\left(-\bar{\gamma}_{m}^{-1} t+k\right), m, k \in \mathbb{Z}\right\} \tag{38}
\end{equation*}
$$

This wavelet family is the natural one to consider because the Fourier transform $\widehat{h}_{\infty}(\lambda)$ is the rescaled limit of the original $\widehat{h}_{j}(\lambda)$ as indicated in (6).

A generalized process is indexed not by time but by functions. The generalized Hermite processes for any order $q$ in $\left\{1, \ldots, q_{c}\right\}$ are defined as follows :

Definition 5.1. Let $0<d<1 / 2$ and let $q$ be a positive integer such that $0<q<1 /(1-2 d)$ and $K \geq 0$. Define the set of functions

$$
\mathcal{S}_{q, d}^{(K)}=\left\{\theta, \int_{\mathbb{R}}|\widehat{\theta}(\xi)|^{2}|\xi|^{q-1-2 d q-2 K} \mathrm{~d} \xi<\infty\right\}
$$

where $\widehat{\theta}=\mathfrak{F}[\theta]$. The generalized random process $Z_{q, d}^{(K)}$ is indexed by functions $\theta \in \mathcal{S}_{q, d}^{(K)}$ and is defined as

$$
\begin{equation*}
Z_{q, d}^{(K)}(\theta)=\int_{\mathbb{R}^{q}}^{\prime \prime} \frac{\widehat{\hat{\theta}\left(u_{1}+\cdots+u_{q}\right)}}{\left(\mathrm{i}\left(u_{1}+\cdots+u_{q}\right)\right)^{K}\left|u_{1} \cdots u_{q}\right|^{d}} \mathrm{~d} \widehat{W}\left(u_{1}\right) \cdots \mathrm{d} \widehat{W}\left(u_{q}\right) \tag{39}
\end{equation*}
$$

where $\widehat{\theta}=\mathfrak{F}[\theta]$ as defined in (13).
Now fix $(m, k) \in \mathbb{Z}^{2}$ and choose a function $h_{\infty, m, k}(t), t \in \mathbb{R}$ as in (38), so that

$$
\begin{equation*}
\mathfrak{F}\left[h_{\infty, m, k}\right](\xi)=\mathfrak{F}\left[\bar{\gamma}_{m}^{-1 / 2} h_{\infty}\left(-\bar{\gamma}_{m}^{-1} t+k\right)\right](\xi)=\left(\bar{\gamma}_{m}\right)^{1 / 2} \mathrm{e}^{-\mathrm{i} \bar{\gamma}_{m} \xi} \widehat{h}_{\infty}\left(\bar{\gamma}_{m} \xi\right) . \tag{40}
\end{equation*}
$$

Lemma 5.1. The conditions on $d$ and $q$ in Definition 5.1 ensures the existence of $Z_{q, d}^{(K)}(\theta)$. In particular,

$$
h_{\infty, m, k} \in \mathcal{S}_{q, d}^{(K)} \text { for all } K \in\{0, \ldots, M\}
$$

and hence $Z_{q, d}^{(K)}\left(h_{\infty, m, k}\right)$ is well-defined.
This Lemma is proved in Section 7 .
By setting in (39), $\theta=h_{\infty, m, k}$, defined in (40), we obtain for all $(m, k) \in \mathbb{Z}^{2}$,

$$
Y_{m, k}^{(q, K)}=Z_{q, d}^{(K)}\left(h_{\infty, m, k}\right) .
$$

Hence the right-hand side of (36) are the wavelet coefficients of the generalized process $Z_{q, d}^{(K)}$ with respect to the wavelet family $\left\{h_{\infty, m, k}, m, k \in \mathbb{Z}\right\}$.

In the special case $q=1$ (Gaussian case), this result corresponds to that of Theorem 1(b) and Remark 5 in [1], obtained in the case where $\gamma_{j}=2^{j}$. In this special case, we have $Z_{1, d}^{(K)}=B_{(d+K)}$, where $B_{(d)}$ is the centered generalized Gaussian process such that for all $\theta_{1}, \theta_{2} \in \mathcal{S}_{1, d}^{(0)}$,

$$
\operatorname{Cov}\left(B_{(d)}\left(\theta_{1}\right), B_{(d)}\left(\theta_{2}\right)\right)=\int_{\mathbb{R}}|\lambda|^{-2 d} \widehat{\theta_{1}}(\lambda) \overline{\widehat{\theta}_{2}(\lambda)} \mathrm{d} \lambda
$$

It is interesting to observe that, under additional assumptions on $\theta$, for $K \geq 1, Z_{q, d}^{(K)}(\theta)$ can also be defined by

$$
\begin{equation*}
Z_{q, d}^{(K)}(\theta)=\int_{\mathbb{R}} \tilde{Z}_{q, d}^{(K)}(t) \overline{\theta(t)} \mathrm{d} t \tag{41}
\end{equation*}
$$

where $\left\{\tilde{Z}_{q, d}^{(K)}(t), t \in \mathbb{R}\right\}$ denotes a measurable continuous time process defined by

$$
\begin{equation*}
\tilde{Z}_{q, d}^{(K)}(t)=\int_{\mathbb{R}^{q}} \frac{" \mathrm{e}^{\mathrm{i}\left(u_{1}+\cdots+u_{q}\right) t}-\sum_{\ell=0}^{K-1} \frac{\left(\mathrm{i}\left(u_{1}+\cdots+u_{q}\right) t\right)^{\ell}}{\ell!}}{\left(\mathrm{i}\left(u_{1}+\cdots+u_{q}\right)\right)^{K}\left|u_{1} \cdots u_{q}\right|^{d}} \mathrm{~d} \widehat{W}\left(u_{1}\right) \cdots \mathrm{d} \widehat{W}\left(u_{q}\right), t \in \mathbb{R} . \tag{42}
\end{equation*}
$$

If, in (41) we set $K=1$, we recover the usual Hermite process as defined in 19] which has stationary increments. The process $\tilde{Z}_{q, d}^{(K)}(t)$ can be regarded as the Hermite process $\tilde{Z}_{q, d}^{(1)}(t)$ integrated $K-1$ times. In the special case where $K=q=1$, we recover the Fractional Brownian Motion $\left\{B_{H}(t)\right\}_{t \in \mathbb{R}}$ with Hurst index $H=d+1 / 2 \in(1 / 2,1)$.

In the case $K=0$ we cannot define a random process $Z_{q, d}^{(0)}(t)$ as in (42). The case $K=0$ would correspond to the derivative of the Hermite process $\tilde{Z}_{q, d}^{(1)}(t)$ but the Hermite process is not differentiable and thus the process $\tilde{Z}_{q, d}^{(0)}(t), t \in \mathbb{R}$ is not defined. When $K=0$ one can only consider the generalized process $\tilde{Z}_{q, d}^{(0)}(\theta)$. Relation (42) can be viewed as resulting from (39) and (41) by interverting formally the integral signs.

We now state sufficient conditions on $\theta$ for (41) to hold.
Lemma 5.2. Let $q$ be a positive integer such that $0<q<1 /(1-2 d)$ and $K \geq 1$. Suppose that $\theta \in \mathcal{S}_{q, \delta}^{(K)}$ is complex valued with at least $K$ vanishing moments, that is,

$$
\begin{equation*}
\int_{\mathbb{R}} \theta(t) t^{\ell} \mathrm{d} t=0 \quad \text { for all } \quad \ell=0,1, \ldots, K-1 \tag{43}
\end{equation*}
$$

Suppose moreover that

$$
\begin{equation*}
\int_{\mathbb{R}}|\theta(t)||t|^{K+(d-1 / 2) q} \mathrm{~d} t<\infty \tag{44}
\end{equation*}
$$

Then Relation (41) holds.
This lemma is proved in Section 7
If, for example, the $h_{j}$ are derived from a compactly supported multiresolution analysis then $h_{\infty}$ will have compact support and so $h_{\infty, m, k}$ will satisfy (44). In this case, the limits $Y_{m, k}^{(q, K)}$ in Theorem 5.1] can therefore be interpreted, for $m, k \in \mathbb{Z}$ as the wavelet coefficients of the process $Z_{q, d}^{(K)}$ belonging to the $q$-th chaos. This interpretation is a useful one even when the technical assumption (44) is not satisfied.

## Self-similarity.

The processes $Z_{q, d}^{(K)}$ and $\tilde{Z}_{q, d}^{(K)}$ are self-similar. Self-similarity can be defined for processes indexed by $t \in \mathbb{R}$ as well as for generalized processes indexed by functions $\theta$ belonging to some suitable space $\mathcal{S}$, for example the space $\mathcal{S}_{q, \delta}^{(K)}$ defined above.

A process $\{Z(t), t \in \mathbb{R}\}$ is said to be self-similar with parameter $H>0$ if for any $a>0$,

$$
\left\{a^{H} Z(t / a), t \in \mathbb{R}\right\} \stackrel{\text { fidi }}{=}\{Z(t), t \in \mathbb{R}\}
$$

where the equality holds in the sense of finite-dimensional distributions. A generalized process $\{Z(\theta), \theta \in \mathcal{S}\}$ is said to be self-similar with parameter $H>0$ if for any $a>0$ and $\theta \in \mathcal{S}$,

$$
Z\left(\theta^{a, H}\right) \stackrel{\mathrm{d}}{=} Z(\theta),
$$

where $\theta^{a, H}(u)=a^{-H} \theta(u / a)$ (see [17], Page 5). Here $\mathcal{S}$ is assumed to contain both $\theta^{a, H}$ and $\theta$.

Observe that the process $\left\{\tilde{Z}_{q, d}^{(K)}(t), t \in \mathbb{R}\right\}$, with $K \geq 1$ is self-similar with parameter

$$
\begin{equation*}
H=K+q d-q / 2=(K-1)+(d(q)+1 / 2) \tag{45}
\end{equation*}
$$

As noted above $\tilde{Z}_{q, d}^{(K)}$ can be regarded as $\tilde{Z}_{q, d}^{(1)}$ integrated $K-1$ times.
The generalized process $\left\{Z_{q, d}^{(K)}(\theta), \theta \in \mathcal{S}_{q, \delta}^{(K)}\right\}$, which is defined in (39) with $K \geq 0$, is self-similar with the same value of $H$ as in (45), but this time the formula is also valid for $K=0$.

In particular, the Hermite process $(K=1)$ is self-similar with $H=d(q)+1 / 2 \in(1 / 2,1)$ and the generalized process $Z_{q, d}^{(0)}(\theta)$ with $K=0$ is self-similar with $H=d(q)-1 / 2 \in$ $(-1 / 2,0)$.

## Interpretation of the result.

In view of the preceding discussion, the wavelet coefficients of the subordinated process $Y$ behave at large scales $\left(\gamma_{j} \rightarrow \infty\right)$ as those of a self-similar process $Z_{q, d}^{(K)}$ living in the chaos of order $q_{0}$ (the Hermite rank of $G$ ) and with self-similar parameter $K+d\left(q_{0}\right)-1 / 2$.

## 6. Proof of Theorem 5.1

Notation. It will be convenient to use the following notation. We denote by $\Sigma_{q}, q \geq 1$, the $\mathbb{C}^{q} \rightarrow \mathbb{C}$ function defined, for all $y=\left(y_{1}, \ldots, y_{q}\right)$ by

$$
\begin{equation*}
\Sigma_{q}(y)=\sum_{i=1}^{q} y_{i} \tag{46}
\end{equation*}
$$

With this notation $Y_{m, k}^{(q, K)}$ in Theorem 5.1 can be expressed as

$$
Y_{m, k}^{(q, K)}=\left(\bar{\gamma}_{m}\right)^{1 / 2} \int_{\mathbb{R}^{q}}^{\prime \prime} \frac{\exp \circ \Sigma_{q}\left(\mathrm{i} k \bar{\gamma}_{m} \zeta\right)}{\left(\Sigma_{q}(\mathrm{i} \zeta)\right)^{K}} \cdot \frac{\widehat{h}_{\infty} \circ \Sigma_{q}\left(\bar{\gamma}_{m} \zeta\right)}{\left|\zeta_{1}\right|^{d} \cdots\left|\zeta_{q}\right|^{d}} \mathrm{~d} \widehat{W}\left(\zeta_{1}\right) \cdots \mathrm{d} \widehat{W}\left(\zeta_{q}\right)
$$

where $\circ$ denotes the composition of functions.
We will separate the Wiener chaos expansion (28) of $W_{j, k}$ into two terms depending on the position of $q$ with respect to $q_{c}$. The first term includes only the $q$ 's for which $H_{q}(x)$ exhibits long-range dependence (LD), that is,

$$
\begin{equation*}
W_{j, k}^{(L D)}=\sum_{q=0}^{q_{c}} \frac{c_{q}}{q!} W_{j, k}^{(q)}, \tag{47}
\end{equation*}
$$

and the second term includes the terms which exhibit short-range dependence (SD)

$$
\begin{equation*}
W_{j, k}^{(S D)}=\sum_{q=q_{c}+1}^{\infty} \frac{c_{q}}{q!} W_{j, k}^{(q)} . \tag{48}
\end{equation*}
$$

Using Representation (14) and (27) since $X$ has unit variance, one has for any $\ell \in \mathbb{Z}$,

$$
\begin{aligned}
H_{q}\left(X_{\ell}\right) & =H_{q}\left(\int_{-\pi}^{\pi} \mathrm{e}^{\mathrm{i} \xi \ell} f^{1 / 2}(\xi) \mathrm{d} \widehat{W}(\xi)\right) \\
& =\int_{(-\pi, \pi]^{q}}^{\prime \prime} \exp \circ \Sigma_{q}(\mathrm{i} \ell \xi) \times\left(f^{\otimes q}(\xi)\right)^{1 / 2} \mathrm{~d} \widehat{W}\left(\xi_{1}\right) \cdots \mathrm{d} \widehat{W}\left(\xi_{q}\right)
\end{aligned}
$$

Then by (29), (10) and (9), we have

$$
\begin{aligned}
W_{j, k}^{(q)} & =\sum_{\ell \in \mathbb{Z}} h_{j}^{(K)}\left(\gamma_{j} k-\ell\right) H_{q}\left(X_{\ell}\right) \\
& =\sum_{\ell \in \mathbb{Z}} h_{j}^{(K)}\left(\gamma_{j} k-\ell\right) \int_{(-\pi, \pi]^{q}}^{\prime \prime} \exp \circ \Sigma_{q}(\mathrm{i} \ell \xi) \times\left(f^{\otimes q}(\xi)\right)^{1 / 2} \mathrm{~d} \widehat{W}\left(\xi_{1}\right) \cdots \mathrm{d} \widehat{W}\left(\xi_{q}\right) \\
& =\int_{(-\pi, \pi]^{q}}^{\prime \prime}\left(\sum_{\ell \in \mathbb{Z}} h_{j}^{(K)}\left(\gamma_{j} k-\ell\right) \exp \circ \Sigma_{q}(\mathrm{i} \ell \xi)\right)\left(f^{\otimes q}(\xi)\right)^{1 / 2} \mathrm{~d} \widehat{W}\left(\xi_{1}\right) \cdots \mathrm{d} \widehat{W}\left(\xi_{q}\right) \\
& =\int_{(-\pi, \pi]^{q}}^{\prime \prime} \mathrm{e}^{\Sigma_{q}\left(\mathrm{i} \gamma_{j} k \xi\right)}\left(\sum_{m \in \mathbb{Z}} h_{j}^{(K)}(m) \exp \circ \Sigma_{q}(-\mathrm{i} m \xi)\right)\left(f^{\otimes q}(\xi)\right)^{1 / 2} \mathrm{~d} \widehat{W}\left(\xi_{1}\right) \cdots \mathrm{d} \widehat{W}\left(\xi_{q}\right) \\
& =\int_{(-\pi, \pi]^{q}}^{\prime \prime} \mathrm{e}^{\Sigma_{q}\left(\mathrm{i} \gamma_{j} k \xi\right)}\left(\widehat{h}_{j}^{(K)} \circ \Sigma_{q}(\xi)\right)\left(f^{\otimes q}(\xi)\right)^{1 / 2} \mathrm{~d} \widehat{W}\left(\xi_{1}\right) \cdots \mathrm{d} \widehat{W}\left(\xi_{q}\right)
\end{aligned}
$$

Then

$$
\begin{equation*}
W_{j, k}^{(q)}=\widehat{I}_{q}\left(f_{j, k}^{(q)}\right), \tag{49}
\end{equation*}
$$

with

$$
f_{j, k}^{(q)}(\xi)=\left(\exp \circ \Sigma_{q}\left(\mathrm{i} k \gamma_{j} \xi\right)\right)\left(\widehat{h}_{j}^{(K)} \circ \Sigma_{q}(\xi)\right)\left(f^{\otimes q}(\xi)\right)^{1 / 2} \times \mathbb{1}_{(-\pi, \pi)}^{\otimes q}(\xi)
$$

where $\xi=\left(\xi_{1}, \cdots, \xi_{q}\right)$ and $f^{\otimes q}(\xi)=f\left(\xi_{1}\right) \cdots f\left(\xi_{q}\right)$.
The two following results provide the asymptotic behavior of each term of the sum in (47) and of $W_{j, k}^{(S D)}$, respectively. They are proved in Sections 6.1 and 6.2, respectively. The first result concerns the terms with long memory, that is, with $q \leq q_{c}$. The second result concerns the terms with short memory for which $q>q_{c}$.

Proposition 6.1. Suppose that $q \in\left\{1, \ldots, q_{c}\right\}$. Then, as $j \rightarrow \infty$,

$$
\begin{equation*}
\left(\gamma_{j}^{-(d(q)+K)} W_{j+m, k}^{(q)}, m, k \in \mathbb{Z}\right) \xrightarrow{f f d i}\left(\left(f^{*}(0)\right)^{q / 2} Y_{m, k}^{(q, K)}, m, k \in \mathbb{Z}\right), \tag{50}
\end{equation*}
$$

where $Y_{m, k}^{(q, K)}$ is given by (37).

Proposition 6.2. We have, for any $k \in \mathbb{Z}$, as $j \rightarrow \infty$,

$$
\begin{equation*}
W_{j+m, k}^{(S D)}=O_{P}\left(\gamma_{j}^{K}\right) \tag{51}
\end{equation*}
$$

It follows from Proposition 6.1 that the dominating term in (47) is given by the chaos of order $q=q_{0}$. Now, since $d\left(q_{0}\right)>0$ by (32), we get from Proposition 6.2 that, for all $(k, m)$, as $j \rightarrow \infty$,

$$
W_{j+m, k}^{(S D)}=o_{p}\left(\gamma_{j}^{d\left(q_{0}\right)+K}\right) .
$$

This concludes the proof of Theorem 5.1.

### 6.1. Proof of Proposition 6.1

We first express the distribution of $\left\{W_{j+m, k}^{(q)}, m, k \in \mathbb{Z}\right\}$ as a finite sum of stochastic integrals and then show that each integral converges in $L^{2}(\Omega)$.

Lemma 6.1. Let $q \in \mathbb{N}^{*}$. For any $j$

W_{j+m, k}^{(q)} \stackrel{(f d i)}{=} \sum_{s=-[q / 2]}^{[q / 2]} W_{m, k}^{(j, q, s)}, \tag{52}
\end{equation*}
$$

where $[a]$ denotes the integer part of $a$, and for any $q \in \mathbb{N}^{*}, s \in \mathbb{Z}$,

$$
\begin{equation*}
W_{m, k}^{(j, q, s)}=\int_{\zeta \in \mathbb{R}^{q}}^{\prime \prime} \mathbb{1}_{\Gamma^{(q, s)}}\left(\gamma_{j}^{-1} \zeta\right) f_{m, k}(\zeta ; j, q) \mathrm{d} \widehat{W}\left(\zeta_{1}\right) \cdots \mathrm{d} \widehat{W}\left(\zeta_{q}\right), \tag{53}
\end{equation*}
$$

where $f_{m, k}(\zeta ; j, q)$ is defined by (setting $\xi=\gamma_{j}^{-1} \zeta$ )

$$
\begin{equation*}
f_{m, k}\left(\gamma_{j} \xi ; j, q\right)=\gamma_{j}^{-q / 2} \frac{\exp \circ \Sigma_{q}\left(\mathrm{i} \gamma_{j+m} k \xi\right) \times \widehat{h}_{j+m} \circ \Sigma_{q}(\xi)}{\left\{1-\exp \circ \Sigma_{q}(-\mathrm{i} \xi)\right\}^{K}}\left(f^{\otimes q}(\xi)\right)^{1 / 2} \tag{54}
\end{equation*}
$$

and where

$$
\begin{equation*}
\Gamma^{(q, s)}=\left\{\xi \in(-\pi, \pi]^{q},-\pi+2 s \pi<\sum_{i=1}^{q} \xi_{i} \leq \pi+2 s \pi\right\} \tag{55}
\end{equation*}
$$

Proof. Using (49), with $j$ replaced by $j+m$, and (9), we get

$$
W_{j+m, k}^{(q)}=\int_{(-\pi, \pi]^{q}}^{\prime \prime} \exp \circ \Sigma_{q}\left(\mathrm{i} \gamma_{j+m} k \xi\right) \frac{\widehat{h}_{j+m} \circ \Sigma_{q}(\xi)}{\left\{1-\exp \circ \Sigma_{q}(\mathrm{i} \xi\}^{K}\right.}\left(f^{\otimes q}(\xi)\right)^{1 / 2} \mathrm{~d} \widehat{W}\left(\xi_{1}\right) \cdots \mathrm{d} \widehat{W}\left(\xi_{q}\right) .
$$

By (54), we thus get

$$
\begin{align*}
& W_{j+m, k}^{(q)}=\int_{\xi \in(-\pi, \pi]^{q}}^{\prime \prime} \gamma_{j}^{q / 2} f_{m, k}\left(\gamma_{j} \xi ; j, q\right) \mathrm{d} \widehat{W}\left(\xi_{1}\right) \cdots \mathrm{d} \widehat{W}\left(\xi_{q}\right)  \tag{56}\\
& \stackrel{(\text { fidi) }}{=} \int_{\zeta \in\left(-\gamma_{j} \pi, \gamma_{j} \pi\right]^{q}}^{\prime \prime} f_{m, k}(\zeta ; j, q) \mathrm{d} \widehat{W}\left(\zeta_{1}\right) \cdots \mathrm{d} \widehat{W}\left(\zeta_{q}\right),
\end{align*}
$$

where we set $\zeta=\gamma_{j} \xi$ (see Theorem 4.4 in [17]). Observe that for all $\zeta \in\left(-\gamma_{j} \pi, \gamma_{j} \pi\right]^{q}$,

$$
-\pi \gamma_{j}-2[q / 2] \pi \gamma_{j} \leq-q \gamma_{j} \pi \leq \sum_{i=1}^{q} \zeta_{i} \leq q \gamma_{j} \pi \leq \pi \gamma_{j}+2[q / 2] \pi \gamma_{j}
$$

The result follows by using that for any $\zeta \in\left(-\gamma_{j} \pi, \gamma_{j} \pi\right]^{q}$, there is a unique $s=-[q / 2], \ldots,[q / 2]$ such that $\zeta / \gamma_{j} \in \Gamma^{(q, s)}$.

Proof of Proposition 6.1, In view of Lemma 6.1, we shall look at the $L^{2}(\Omega)$ convergence of the normalized $W_{m, k}^{(j, q, s)}$ at each value of $s$. Proposition 6.1 will follow from the following convergence results, valid for all fixed $m, k \in \mathbb{Z}$ as $j \rightarrow \infty$. For $s=0$,

$$
\begin{equation*}
\gamma_{j}^{-(d(q)+K)} W_{m, k}^{(j, q, 0)} \xrightarrow{L^{2}}\left(f^{*}(0)\right)^{q / 2} Y_{m, k}^{(q, K)}, \tag{57}
\end{equation*}
$$

whereas for other values of $s$, namely for all $s \in\{-[q / 2], \ldots,-1,1, \ldots,[q / 2]\}$,

$$
\begin{equation*}
\gamma_{j}^{-(d(q)+K)} W_{m, k}^{(j, q, s)} \xrightarrow{L^{2}} 0, \tag{58}
\end{equation*}
$$

where $d(q)$ is defined in (31).
We now prove these convergence using the representation (53). By (11) and $\left|1-\mathrm{e}^{\mathrm{i} \lambda}\right| \geq$ $2|\lambda| / \pi$ on $\lambda \in(-\pi, \pi)$, we have that

$$
\begin{equation*}
f(\lambda) \leq\left(\frac{\pi}{2}\right)^{-2 d}\left\|f^{*}\right\|_{\infty}|\lambda|^{-2 d}, \quad \lambda \in[-\pi, \pi] \tag{59}
\end{equation*}
$$

By definition of $\Gamma^{(q, s)}$ in (55), we have, for all $\zeta \in \gamma_{j} \Gamma^{(q, s)}, \gamma_{j}^{-1} \sum_{i} \zeta_{i}-2 \pi s \in(-\pi, \pi]$. Hence using the $(2 \pi)$-periodicity of $\widehat{h}_{j+m}$, we can use (4) for bounding $\widehat{h}_{j+m}\left(\gamma_{j}^{-1} \sum_{i} \zeta_{i}\right)$. With the change of variables $\zeta=\gamma_{j} \xi$ and (59) , for all $\zeta \in \gamma_{j} \Gamma^{(q, s)}$ and $j$ large enough so that $\gamma_{j+m} / \gamma_{j} \geq \bar{\gamma}_{m} / 2$,

$$
\begin{equation*}
\gamma_{j}^{-(d(q)+K)}\left|f_{m, k}(\zeta ; j, q)\right|=\gamma_{j}^{-(d q-q / 2+1 / 2+K)}\left|f_{m, k}(\zeta ; j, q)\right| \leq C_{0} g\left(\zeta ; 2 \pi \gamma_{j} s\right) \tag{60}
\end{equation*}
$$

where $C_{0}$ is a positive constant and

$$
g(\zeta ; t)=\left(1+\left|\sum_{i=1}^{q} \zeta_{i}-t\right|\right)^{-\alpha-K} \prod_{i=1}^{q}\left|\zeta_{i}\right|^{-d}
$$

The squared $L^{2}$-norm of $g(\cdot ; t)$ reads

$$
J(t)=\int_{\mathbb{R}^{d}} g^{2}(\zeta ; t) \mathrm{d} \zeta=\int_{\mathbb{R}^{q}}\left(1+\left|\sum_{i=1}^{q} \zeta_{i}-t\right|\right)^{-2 \alpha-2 K} \prod_{i=1}^{q}\left|\zeta_{i}\right|^{-2 d} \prod_{i=1}^{q} \mathrm{~d} \zeta_{i}
$$

We now show that Lemma 8.4 applies with $M_{1}=2 \alpha+2 K, M_{2}=0$ and $\beta_{i}=2 d$ for $i=1, \ldots, q$. Indeed, we have $M_{2}-M_{1}=-2 \alpha-2 K \leq-2 \alpha<-1$. Further, for all $\ell=1, \ldots, q-1$, we have, by the assumption on $d$,

$$
\sum_{i=\ell}^{q} \beta_{i}=2 d(1+q-\ell)>(1+q-\ell)(1-1 / q)=q-\ell+(\ell-1) / q \geq q-\ell
$$

Finally, since $\alpha>1 / 2$, one has $M_{2}-M_{1}+q=-2 \alpha-2 K+q<q-1 \leq \sum_{i} \beta_{i}$.
Applying Lemma [8.4, we get $J(t) \rightarrow 0$ as $|t| \rightarrow \infty$ and $J(0)<\infty$. Thus, if $s \neq 0$, one has $t=2 \pi \gamma_{j} s \rightarrow \infty$ as $j \rightarrow \infty$ and hence we obtain (58). If $s=0$, then $t=2 \pi \gamma_{j} s=0$ and using the bound (60), $J(0)<\infty$, and the dominated convergence theorem, we have that the convergence (57) follows from the convergence at a.e. $\zeta \in \mathbb{R}^{q}$ of the left hand side of (60), which we now establish. Recall that $f_{m, k}$ is defined in (54). By (6), (11) and the continuity of $f^{*}$ at the origin, we have, as $j \rightarrow \infty$,

\begin{aligned}
\gamma_{j}^{-1 / 2} \widehat{h}_{j+m} \circ \Sigma_{q}\left(\zeta / \gamma_{j}\right) & =\left(\frac{\gamma_{j+m}}{\gamma_{j}}\right)^{1 / 2} \gamma_{j+m}^{-1 / 2} \widehat{h}_{j+m} \circ \Sigma_{q}\left(\left(\zeta / \gamma_{j+m}\right)\left(\gamma_{j+m} / \gamma_{j}\right)\right) \\
& \rightarrow \bar{\gamma}_{m}^{1 / 2} \widehat{h}_{\infty}\left(\bar{\gamma}_{m}\left(\zeta_{1}+\cdots+\zeta_{q}\right)\right)
\end{aligned}
$$

and for every $\ell=1, \cdots, q$

$$
\gamma_{j}^{-2 d} f\left(\zeta_{l} / \gamma_{j}\right)=\gamma_{j}^{-2 d}\left|1-\mathrm{e}^{-\mathrm{i} \zeta_{l} / \gamma_{j}}\right|^{-2 d} f^{*}\left(\zeta_{l} / \gamma_{j}\right) \rightarrow f^{*}(0)\left|\zeta_{l}\right|^{-2 d}
$$

Hence $\gamma_{j}^{-(d(q)+K)} f_{m, k}(\zeta ; j, q, 0) \mathbb{1}_{\Gamma^{(q, s)}}\left(\gamma_{j}^{-1} \zeta\right)$ converges to

$$
\left(\bar{\gamma}_{m}\right)^{1 / 2}\left(f^{*}(0)\right)^{q / 2} \frac{\mathrm{e}^{\mathrm{i} k \bar{\gamma}_{m}\left(\zeta_{1}+\cdots+\zeta_{q}\right)} \times \widehat{h}_{\infty}\left(\bar{\gamma}_{m}\left(\zeta_{1}+\cdots+\zeta_{q}\right)\right)}{\left(\mathrm{i}\left(\zeta_{1}+\cdots+\zeta_{q}\right)\right)^{K}\left|\zeta_{1}\right|^{d} \cdots\left|\zeta_{q}\right|^{d}}
$$

This concludes the proof.

### 6.2. Proof of Proposition 6.2

We now consider the short-range dependence part of the wavelet coefficients ( $W_{j, k}$ ) defined by (29) and (48). These wavelet coefficients can be equivalently defined as

$$
\begin{equation*}
W_{j, k}^{(S D)}=\sum_{\ell \in \mathbb{Z}} h_{j}^{(K)}\left(\gamma_{j} k-\ell\right) \Delta^{K} Y_{\ell}^{(S D)} \tag{61}
\end{equation*}
$$

where we have set

$$
\Delta^{K} Y_{\ell}^{(S D)}=\sum_{q \geq q_{c}+1} \frac{c_{q}}{q!} H_{q}\left(X_{\ell}\right), \quad \ell \in \mathbb{Z}
$$

Using Lemma 4.1, since (26) holds and $\left\{H_{q}\left(X_{\ell}\right)\right\}_{\ell \in \mathbb{Z}}$ are uncorrelated weakly stationary processes, the process $\left\{\Delta^{K} Y_{\ell}^{(S D)}\right\}_{\ell \in \mathbb{Z}}$ is weakly stationary with spectral density

$$
f^{(S D)}(\lambda)=\sum_{q \geq q_{c}+1} \frac{c_{q}^{2}}{q!} f^{(\star q)}(\lambda), \quad \lambda \in(-\pi, \pi)
$$

By Lemma 4.1(ii), we have that $\left\|f^{\left(\star\left\{q_{c}+1\right\}\right)}\right\|_{\infty}<\infty$. Using that $\left\|g_{1} \star g_{2}\right\|_{\infty} \leq\left\|g_{1}\right\|_{\infty}\left\|g_{2}\right\|_{1}$ and $\|f\|_{1}=1$ by assumption, an induction yields

$$
\sup _{q>q_{c}}\left\|f^{(\star q)}\right\|_{\infty} \leq\left\|f^{\left(\star\left\{q_{c}+1\right\}\right)}\right\|_{\infty}
$$

Hence, by (26), we get $\left\|f^{(S D)}\right\|_{\infty}<\infty$. It follows that, for $W_{j, k}^{(S D)}$ defined in (61), there is a positive constant $C$ such that,

$$
\mathbb{E}\left[W_{j, k}^{(S D) 2}\right] \leq\left\|f^{(S D)}\right\|_{\infty} \int_{-\pi}^{\pi}\left|\widehat{h}_{j}^{(K)}(\lambda)\right|^{2} \mathrm{~d} \lambda \leq C \int_{0}^{\pi}|\lambda|^{-2 K}\left|\widehat{h}_{j}(\lambda)\right|^{2} \mathrm{~d} \lambda=O\left(\gamma_{j}^{2 K}\right),
$$

where we used (4) with $M \geq K$ and $\alpha>1 / 2$. This last relation implies (51) and concludes the proof of Proposition 6.2.

## 7. Proof of Lemmas 5.1 and 5.2

### 7.1. Proof of Lemma 5.1

Let us first prove that if $\theta \in \mathcal{S}_{q, d}^{(K)}$ then $Z_{q, d}^{(K)}(\theta)$ exists. Indeed, by Definition 5.1, $Z_{q, d}^{(K)}(\theta)$ exists if

$$
\begin{equation*}
\int_{\mathbb{R}^{q}} \frac{\left|\widehat{\theta}\left(u_{1}+\cdots+u_{q}\right)\right|^{2}}{\left|u_{1}+\cdots+u_{q}\right|^{2 K}\left|u_{1} \cdots u_{q}\right|^{2 d}} \mathrm{~d} u_{1} \cdots \mathrm{~d} u_{q}<\infty \tag{62}
\end{equation*}
$$

Use now Lemma 8.3 with $\beta_{1}=\cdots=\beta_{q}=-2 d$ and $f(x)=|\widehat{\theta}(x)|^{2} /|x|^{2 K}$ and deduce that Condition (62) is equivalent to

$$
\begin{equation*}
\Gamma \int_{\mathbb{R}}|\widehat{\theta}(s)|^{2}|s|^{q-1-2 q d-2 K} \mathrm{~d} s<\infty \tag{63}
\end{equation*}
$$

where

$$
\Gamma=\prod_{i=2}^{q}\left(\int_{\mathbb{R}}|t|^{q-i-2 d(q-i+1)}|1-t|^{-2 d} \mathrm{~d} t\right)
$$

Note that the conditions $0<d<1 / 2$ and $0<q<1 /(1-2 d)$ ensure that $\Gamma$ is finite. Further, Relation (63) implies $\theta \in \mathcal{S}_{q, d}^{(K)}$.

We now prove that for any $m, k, h_{\infty, m, k} \in \mathcal{S}_{q, d}^{(K)}$ when $K \in\{0, \ldots, M\}$. By Definition (40) of $h_{\infty, m, k}$

$$
\widehat{h}_{\infty, m, k}(\xi)=\left(\bar{\gamma}_{m}\right)^{1 / 2} \mathrm{e}^{-\mathrm{i} \bar{\gamma}_{m} \xi} \overline{\widehat{h}_{\infty}\left(\bar{\gamma}_{m} \xi\right)}
$$

Hence

$$
\int_{\mathbb{R}}\left|\widehat{h}_{\infty, m, k}(s)\right|^{2}|s|^{q-1-2 q d-2 K} \mathrm{~d} s=\bar{\gamma}_{m} \int_{\mathbb{R}}\left|\widehat{h}_{\infty}\left(\bar{\gamma}_{m} s\right)\right|^{2}|s|^{q-1-2 q d-2 K} \mathrm{~d} s
$$

Set $v=\bar{\gamma}_{m} s$ and deduce that $h_{\infty, m, k} \in \mathcal{S}_{q, d}^{(K)}$ is equivalent to

$$
\bar{\gamma}_{m}^{2-(q-1-2 q d-2 K)} \int_{\mathbb{R}}\left|\widehat{h}_{\infty}(v)\right|^{2}|v|^{q-1-2 q d-2 K} \mathrm{~d} v<\infty
$$

Assumption (12) implies that

$$
\int_{\mathbb{R}}\left|\widehat{h}_{\infty}(v)\right|^{2}|v|^{q-1-2 q d-2 K} \mathrm{~d} v \leq \int_{\mathbb{R}} \frac{|v|^{2 M}}{(1+|v|)^{2 M+2 \alpha}}|v|^{q-1-2 q d-2 K} \mathrm{~d} v
$$

Since $M \geq K$ and $q(1-2 d) \in(0,1)$ then $2 M+q-1-2 q d-2 K=(2 M-2 K)+q(1-2 d)-1>$ -1 . Further $\alpha>1 / 2$ and $q(1-2 d) \in(0,1)$ imply that $2 M-2 M-2 \alpha+(q-1-2 q d-2 K)=$ $-2 \alpha-2 K+q(1-2 d)-1<-1$. Then

$$
\int_{\mathbb{R}}\left|\widehat{h}_{\infty, m, k}(s)\right|^{2}|s|^{q-1-2 q d-2 K} \mathrm{~d} s<\infty
$$

holds and $h_{\infty, m, k} \in \mathcal{S}_{q, d}^{(K)}$.

### 7.2. Proof of Lemma 5.2

Let $a_{t}\left(u_{1}, \cdots, u_{q}\right)$ denote the kernel of the integral in (42) defining $\tilde{Z}_{q, d}^{(K)}$ and suppose we can exchange the order of integration and write

$$
\begin{equation*}
\int_{\mathbb{R}} \tilde{Z}_{q, d}^{(K)}(t) \theta(t) \mathrm{d} t=\int_{\mathbb{R}^{q}}^{\prime \prime}\left[\int_{\mathbb{R}} a_{t}\left(u_{1}, \cdots, u_{q}\right) \theta(t) \mathrm{d} t\right] \mathrm{d} \widehat{W}\left(u_{1}\right) \cdots \mathrm{d} \widehat{W}\left(u_{q}\right) \tag{64}
\end{equation*}
$$

Then condition (43) gives

$$
\int_{\mathbb{R}}\left[\mathrm{e}^{\mathrm{i} t\left(u_{1}+\cdots+u_{q}\right)}-\sum_{\ell=0}^{K-1} \frac{\left(\mathrm{i} t\left(u_{1}+\cdots+u_{q}\right)\right)^{\ell}}{\ell!}\right] \overline{\theta(t)} \mathrm{d} t=\int_{\mathbb{R}} \mathrm{e}^{\mathrm{i} t\left(u_{1}+\cdots+u_{q}\right)} \overline{\theta(t)} \mathrm{d} t=\overline{\hat{\theta} \circ \Sigma_{q}(u)},
$$

showing that (64) equals $\tilde{Z}_{q, d}^{(K)}(\theta)$ defined in (39). It remains to justify the change of order of integration in (64) by using a stochastic Fubini theorem, (see for instance [20, Theorem 2.1]). A sufficient condition is

$$
\int_{\mathbb{R}}\left(a_{t}^{2}\left(u_{1}, \cdots, u_{q}\right) \mathrm{d} u_{1} \cdots \mathrm{~d} u_{q}\right)^{1 / 2} \mathrm{~d} t<\infty
$$

This condition is satisfied, because setting $v=t u$, we have

$$
\begin{gathered}
\int_{\mathbb{R}^{q}}\left|\mathrm{e}^{\mathrm{i} t\left(u_{1}+\cdots+u_{q}\right)}-\sum_{\ell=0}^{K-1} \frac{\left(\mathrm{i} t\left(u_{1}+\cdots+u_{q}\right)\right)^{\ell}}{\ell!}\right|^{2}\left|\mathrm{i}\left(u_{1}+\cdots+u_{q}\right)\right|^{-2 K}\left|u_{1} \cdots u_{q}\right|^{-2 d} \mathrm{~d}^{q} u \\
\leq|t|^{2 K+2 d-q} \int_{\mathbb{R}^{q}}\left(1+\left|u_{1}+\cdots+u_{q}\right|\right)^{-2 K}\left|u_{1} \cdots u_{q}\right|^{-2 d} \mathrm{~d}^{q} u
\end{gathered}
$$

## 8. Auxiliary lemmas

The following lemma provides a bound for the convolution of two functions exploding at the origin and decaying polynomially at infinity.

Lemma 8.1. Let $\alpha>1$ and $\beta_{1}, \beta_{2} \in[0,1)$ such that $\beta_{1}+\beta_{2}<1$, and set

$$
g_{i}(t)=|t|^{-\beta_{i}}(1+|t|)^{\beta_{i}-\alpha} .
$$

Then

$$
\begin{equation*}
\sup _{u \in \mathbb{R}}\left((1+|u|)^{\alpha} \int_{\mathbb{R}} g_{1}(u-t) g_{2}(t) \mathrm{d} t\right)<\infty . \tag{65}
\end{equation*}
$$

Proof. We first show that

$$
J(u)=\int_{\mathbb{R}} g_{1}(u-t) g_{2}(t) \mathrm{d} t=\int_{\mathbb{R}}|u-t|^{-\beta_{1}}(1+|u-t|)^{\beta_{1}-\alpha}|t|^{-\beta_{2}}(1+|t|)^{\beta_{2}-\alpha} \mathrm{d} t
$$

is uniformly bounded on $\mathbb{R}$. Using the assumptions on $\beta_{1}, \beta_{2}$, there exist $p>1$ such that $\beta_{1}<1 / p<1-\beta_{2}$. Let $q$ be such that $1 / p+1 / q=1$. The Hölder inequality implies that

$$
J(u)^{p q} \leq \int_{\mathbb{R}}|t|^{-p \beta_{1}}(1+|t|)^{p \beta_{1}-p \alpha} \mathrm{~d} t \times \int_{\mathbb{R}}|t|^{-q \beta_{2}}(1+|t|)^{q \beta_{2}-q \alpha} \mathrm{~d} t
$$

The condition on $\alpha, \beta_{1}, \beta_{2}, p$ and the definition of $q$ imply that these two integrals are finite. Hence $\sup _{u} J(u)<\infty$.

We now determine how fast $J(u)$ tends to 0 as $u \rightarrow \infty$. Observe that, if $|t-u| \leq|u| / 2$, then $|t| \geq|u| / 2$. By splitting the integral in two integrals on the domains $|t-u| \leq|u| / 2$ and $|t-u|>|u| / 2$, we get $J(u) \leq J_{1}(u)+J_{2}(u)$ with

$$
J_{1}(u) \leq(|u| / 2)^{-\beta_{2}}(1+|u| / 2)^{\beta_{2}-\alpha} \int_{\mathbb{R}}|u-t|^{-\beta_{1}}(1+|t-u|)^{\beta_{1}-\alpha} \mathrm{d} t
$$

and

$$
J_{2}(u) \leq(|u| / 2)^{-\beta_{1}}(1+|u| / 2)^{\beta_{1}-\alpha} \int_{\mathbb{R}}|t|^{-\beta_{2}}(1+|t|)^{\beta_{2}-\alpha} \mathrm{d} t
$$

Now, as $|u| \rightarrow \infty$, we have $J_{i}(u)=O\left(|u|^{-\alpha}\right)$ for $i=1,2$, which achieves the proof.
The next lemma describes the convolutions of two periodic functions that explode at the origin as a power. A different definition of convolution is involved here (see (33)).

Lemma 8.2. Let $\left(\beta_{1}, \beta_{2}\right) \in(0,1)^{2}$. Let $g_{1}, g_{2}$ be $(2 \pi)$-periodic functions such that $g_{i}(\lambda)=$ $|\lambda|^{-\beta_{i}} g_{i}^{*}(\lambda), i=1,2$. Each $g_{i}^{*}(\lambda)$ is a $(2 \pi)$-periodic non-negative function, bounded on $(-\pi, \pi)$ and positive at the origin, where it is also continuous. Let $g=g_{1} \star g_{2}$ as defined in (33). Then,

- If $\beta_{1}+\beta_{2}<1, g$ is bounded and continuous on $(-\pi, \pi)$, and satisfies $g(0)>0$.
- If $\beta_{1}+\beta_{2}>1$,

$$
g(\lambda)=|\lambda|^{-\left(\beta_{1}+\beta_{2}-1\right)} g^{*}(\lambda),
$$

where $g^{*}(\lambda)$ is bounded on $(-\pi, \pi)$ and converges to a positive constant as $\lambda \rightarrow 0$. If moreover for some $\beta \in(0,2]$ such that $\beta<\beta_{1}+\beta_{2}-1$ and some $L>0$, one has for any $i \in\{1,2\}$

$$
\begin{equation*}
\left|g_{i}^{*}(\lambda)-g_{i}^{*}(0)\right| \leq L|\lambda|^{\beta}, \forall \lambda \in(-\pi, \pi), \tag{66}
\end{equation*}
$$

then there exists some $L^{\prime}>0$ depending only on $L, \beta_{1}, \beta_{2}$ such that

$$
\left|g^{*}(\lambda)-g^{*}(0)\right| \leq L^{\prime}|\lambda|^{\beta}, \forall \lambda \in(-\pi, \pi)
$$

Proof. By (33) and (2 2 )-periodicity, we may write

$$
\begin{equation*}
g(\lambda)=\int_{-\pi}^{\pi} g_{1}(u) g_{2}(\lambda-u) \mathrm{d} u=\int_{-\pi}^{\pi}|\{\lambda-u\}|^{-\beta_{1}} g_{1}^{*}(\lambda-u)|u|^{-\beta_{2}} g_{2}^{*}(u) \mathrm{d} u . \tag{67}
\end{equation*}
$$

Let us first consider the case $\beta_{1}+\beta_{2}<1$. We clearly have $g(0)>0$. To prove that $g$ is bounded, we proceed as in the case of convolutions of non-periodic functions (see the proof of Lemma 8.1), namely, for $p, q$ such that $\beta_{1}<1 / p<1-\beta_{2}$ and $1 / p+1 / q=1$, the Hölder inequality gives that

$$
\begin{equation*}
\|g\|_{\infty}^{p q} \leq\left\|g_{1}\right\|_{p}^{p}\left\|g_{2}\right\|_{q}^{q} \leq\left\|g_{1}^{*}\right\|_{\infty}^{p}\left\|g_{2}^{*}\right\|_{\infty}^{q} \int_{-\pi}^{\pi}|t|^{-p \beta_{1}} \mathrm{~d} t \times \int_{-\pi}^{\pi}|t|^{-q \beta_{2}} \mathrm{~d} t<\infty \tag{68}
\end{equation*}
$$

For any $\epsilon>0$ and $i=1,2$, let $g_{\epsilon, i}$ be the $(2 \pi)$-periodic function such that for all $\lambda \in(-\pi, \pi)$, $g_{\epsilon, i}(\lambda)=\mathbb{1}_{(-\epsilon, \epsilon)}(\lambda) g_{i}(\lambda)$ and let $\bar{g}_{\epsilon, i}=g_{i}-g_{\epsilon, i}$. Then $g=\bar{g}_{\epsilon, 1} \star \bar{g}_{\epsilon, 2}+g_{\epsilon, 1} \star \bar{g}_{\epsilon, 2}+\bar{g}_{\epsilon, 1} \star g_{\epsilon, 2}+$ $g_{\epsilon, 1} \star g_{\epsilon, 2}$. Since $\bar{g}_{\epsilon, i}$ is bounded for $i=1,2$, we have that $\bar{g}_{\epsilon, 1} \star \bar{g}_{\epsilon, 2}$ is continuous. On the other hand, using the Hölder inequality as in (68), we get that $\left\|g_{\epsilon, 1} \star \bar{g}_{\epsilon, 2}\right\|_{\infty},\left\|\bar{g}_{\epsilon, 1} \star g_{\epsilon, 2}\right\|_{\infty}$, $\left\|\bar{g}_{\epsilon, 1} \star \bar{g}_{\epsilon, 2}\right\|_{\infty}$ tend to zero as $\epsilon \rightarrow 0$. Hence $g$ is continuous as well.

We now consider the case $\beta_{1}+\beta_{2} \geq 1$. Setting $v=u / \lambda$ in (67), we get, for any $\lambda \in[-\pi, \pi] \backslash\{0\}$,

$$
g^{*}(\lambda)=|\lambda|^{\beta_{1}+\beta_{2}-1} g(\lambda)=\int_{\mathbb{R}} \mathbb{1}_{(-\pi /|\lambda|, \pi /|\lambda|)}(v)\left|\{(1-v)\}_{\lambda}\right|^{-\beta_{1}}|v|^{-\beta_{2}} g_{1}^{*}(\lambda(1-v)) g_{2}^{*}(\lambda v) \mathrm{d} v
$$

where for any real number $x$ and $\lambda \neq 0,\{x\}_{\lambda}$ denotes the unique element of $[-\pi /|\lambda|, \pi /|\lambda|]$ such that $x-\{x\}_{\lambda} \in \mathbb{Z}$. Take now $|\lambda|$ small enough so that $\pi /|\lambda|>2$. Then, for any $v \in(-\pi /|\lambda|+1, \pi /|\lambda|]$, we have $\left|\{(1-v)\}_{\lambda}\right|=|1-v| \geq|1-|v||$ and, for any $v \in(-\pi /|\lambda|,-\pi /|\lambda|+1]$, we have

$$
\begin{equation*}
\left|\{(1-v)\}_{\lambda}\right|=|1-v-2 \pi /|\lambda||=2 \pi /|\lambda|+v-1 \geq-v-1=|1-|v|| \tag{69}
\end{equation*}
$$

Thus we have $\mathbb{1}_{(-\pi /|\lambda|, \pi /|\lambda|)}(v)\left|\{(1-v)\}_{\lambda}\right|^{-\beta_{1}}\left|\leq\left|1-|v|^{-\beta_{1}}\right.\right.$ for all $v \in \mathbb{R}$. We conclude that for $|\lambda|$ small enough, the integrand in the last display is bounded from above by
$|1-|v||^{-\beta_{1}}|v|^{-\beta_{2}}\left\|g_{1}^{*}\right\|_{\infty}\left\|g_{2}^{*}\right\|_{\infty}$, which is integrable on $v \in \mathbb{R}$. Hence $g^{*}$ is bounded, and by dominated convergence, as $\lambda \rightarrow 0$,

$$
\begin{equation*}
g^{*}(\lambda) \rightarrow g_{1}^{*}(0) g_{2}^{*}(0) \int_{\mathbb{R}}|1-v|^{-\beta_{1}}|v|^{-\beta_{2}} \mathrm{~d} v>0 \tag{70}
\end{equation*}
$$

We set $g^{*}(0)$ equal to this limit.
Suppose moreover that $g_{1}^{*}, g_{2}^{*}$ satisfy (66). We take $g_{1}^{*}(0)=g_{2}^{*}(0)=1$ without loss of generality and denote $r_{i}(\lambda)=\left|g_{i}^{*}(\lambda)-1\right|$ for $i=1,2$. Then $r(\lambda)=\left|g^{*}(\lambda)-g^{*}(0)\right|$, where $g^{*}(0)$ is defined as the limit in (70), is at most

$$
\left.\int_{\mathbb{R}}\left|\mathbb{1}_{(-\pi /|\lambda|, \pi /|\lambda|)}(v)\right|\{(1-v)\}_{\lambda}\right|^{-\beta_{1}}|v|^{-\beta_{2}} g_{1}^{*}(\lambda(1-v)) g_{2}^{*}(\lambda v)-|1-v|^{-\beta_{1}}|v|^{-\beta_{2}} \mid \mathrm{d} v .
$$

Setting $g_{i}^{*}(\lambda)=\left(g_{i}^{*}(\lambda)-1\right)+1$, we have $r \leq A+B_{1}+B_{2}+C$ with

$$
\begin{aligned}
A(\lambda) & =\left.\int_{\mathbb{R}}\left|\mathbb{1}_{(-\pi /|\lambda|, \pi /|\lambda|)}(v)\right|\{(1-v)\}_{\lambda}\right|^{-\beta_{1}}|v|^{-\beta_{2}}-|1-v|^{-\beta_{1}}|v|^{-\beta_{2}} \mid \mathrm{d} v, \\
B_{i}(\lambda) & =\int_{\mathbb{R}} \mathbb{1}_{(-\pi /|\lambda|, \pi /|\lambda|)}(v)\left|\{(1-v)\}_{\lambda}\right|^{-\beta_{j}}|v|^{-\beta_{i}} r_{i}(\lambda v) \mathrm{d} v,
\end{aligned}
$$

where $(i, j)$ is $(1,2)$ or $(2,1)$, and

$$
C(\lambda)=\int_{\mathbb{R}} \mathbb{1}_{(-\pi /|\lambda|, \pi /|\lambda|)}(v)\left|\{(1-v)\}_{\lambda}\right|^{-\beta_{1}}|v|^{-\beta_{2}} r_{1}(\lambda(1-v)) r_{2}(\lambda v) \mathrm{d} v
$$

Since $\{(1-v)\}_{\lambda}=1-v$ for $v \in[-\pi /|\lambda|+1, \pi /|\lambda|)$ and $\lambda$ large enough, we have

$$
\begin{aligned}
& A(\lambda)=\int_{(-\pi /|\lambda|, \pi /|\lambda|)^{c}}|1-v|^{-\beta_{1}}|v|^{-\beta_{2}} \mathrm{~d} v \\
& \quad+\left.\int_{-\pi /|\lambda|}^{-\pi /|\lambda|+1}| |\{(1-v)\}_{\lambda}\right|^{-\beta_{1}}|v|^{-\beta_{2}}-|1-v|^{-\beta_{1}}|v|^{-\beta_{2}} \mid \mathrm{d} v .
\end{aligned}
$$

The first integral is $O\left(|\lambda|^{\beta_{1}+\beta_{2}-1}\right)$. Using (69), the second line of the last display is less than

$$
\int_{\pi /|\lambda|-1}^{\pi /|\lambda|}\left[|1-v|^{-\beta_{1}}|v|^{-\beta_{2}}+|1+v|^{-\beta_{1}} v^{-\beta_{2}}\right] \mathrm{d} v=O\left(|\lambda|^{\beta_{1}+\beta_{2}}\right) .
$$

We conclude that as $\lambda \rightarrow 0, A(\lambda)=O\left(|\lambda|^{\beta_{1}+\beta_{2}-1}\right)$. Moreover using that $r_{i}(\lambda) \leq L|\lambda|^{\beta}$ and $\beta_{1}+\beta_{2}-\beta>1$, we have $B_{i}(\lambda)=O\left(|\lambda|^{\beta}\right)$ for $i=1,2$. The same is true for $C$ since $r_{1}$ and $r_{2}$ are also bounded on $\mathbb{R}$. This achieves the proof.

Lemma 8.3. Let $p$ be a positive integer and $f: \mathbb{R} \rightarrow \mathbb{R}_{+}$. Then, for any $\beta \in \mathbb{R}^{q}$,

$$
\begin{equation*}
\int_{\mathbb{R}^{q}} f\left(y_{1}+\cdots+y_{q}\right) \prod_{i=1}^{q}\left|y_{i}\right|^{\beta_{i}} \mathrm{~d} y_{1} \cdots \mathrm{~d} y_{q}=\Gamma \times \int_{\mathbb{R}} f(s)|s|^{q-1+\beta_{1}+\cdots+\beta_{q}} \mathrm{~d} s \tag{71}
\end{equation*}
$$

where, for all $i \in\{1, \cdots, q\}, B_{i}=\beta_{i}+\cdots+\beta_{q}$ and

$$
\Gamma=\prod_{i=2}^{q}\left(\int_{\mathbb{R}}|t|^{q-i+B_{i}}|1-t|^{\beta_{i-1}} \mathrm{~d} t\right)
$$

(We note that $\Gamma$ may be infinite in which case (71) holds with the convention $\infty \times 0=0$ ).

Proof. Relation (71) is obtained by using the following two successive change of variables followed by an application of the Fubini Theorem. Setting, for all $i=1, \cdots, q, u_{i}=$ $\sum_{j=i}^{q} y_{j}$, we get that $y_{i}=u_{i}-u_{i+1}$ for $i<q$ and $y_{q}=u_{q}$. Then the integral in the left-hand side of (71) reads

$$
\begin{equation*}
\int_{\mathbb{R}^{q}} f\left(u_{1}\right)\left[\left|u_{q}\right|^{\beta_{q}} \prod_{i=1}^{q-1}\left|u_{i}-u_{i+1}\right|^{\beta_{i}}\right] \mathrm{d} u_{1} \cdots \mathrm{~d} u_{q} \tag{72}
\end{equation*}
$$

The second change of variables consists in setting, for all $i=1, \cdots, q, u_{i}=\prod_{j=1}^{i} t_{j}$. Then

$$
\begin{gathered}
\mathrm{d} u_{1} \cdots \mathrm{~d} u_{q}=\left(\prod_{i=1}^{q-1} t_{i}^{q-i}\right) \mathrm{d} t_{1} \cdots \mathrm{~d} t_{q} \\
\prod_{i=1}^{q-1}\left|u_{i}-u_{i+1}\right|^{\beta_{i}}=\prod_{i=1}^{q-1}\left(\left|t_{1} \cdots t_{i}\right|^{\beta_{i}}\left|1-t_{i+1}\right|^{\beta_{i}}\right)=\left(\prod_{i=1}^{q-1}\left|t_{i}\right|^{\beta_{i}+\cdots+\beta_{q-1}}\right)\left(\prod_{i=2}^{q}\left|1-t_{i}\right|^{\beta_{i-1}}\right),
\end{gathered}
$$

and $\left|u_{q}\right|=\prod_{i=1}^{q}\left|t_{i}\right|^{\beta_{q}}$, so that (72) becomes

$$
\int_{\mathbb{R}^{q}} f\left(t_{1}\right) \prod_{i=1}^{q}\left|t_{i}\right|^{\beta_{i}+\cdots+\beta_{q}+q-i} \prod_{i=2}^{q}\left|1-t_{i}\right|^{\beta_{i-1}} \mathrm{~d} t_{1} \cdots \mathrm{~d} t_{q},
$$

which by Fubini Theorem yields the required result.

Lemma 8.4. Let $a \in \mathbb{R}$ and $q$ be a positive integer. Let $\beta=\left(\beta_{1}, \cdots, \beta_{q}\right) \in(-\infty, 1)^{q}$, $M_{1}>0$ and $M_{2}>-1$ such that $M_{2}-M_{1}<-1$. Assume that $q+M_{2}-M_{1}<\sum_{i=1}^{q} \beta_{i}$, and that for any $\ell \in\{1, \cdots, q-1\}, \sum_{i=\ell}^{q} \beta_{i}>q-\ell$. Set for any $a \in \mathbb{R}$,

$$
J_{q}\left(a ; M_{1}, M_{2} ; \beta\right)=\int_{\mathbb{R}^{q}} \frac{\left|\Sigma_{q}(\zeta)-a\right|^{M_{2}}}{\left(1+\left|\Sigma_{q}(\zeta)-a\right|\right)^{M_{1}} \prod_{i=1}^{q}\left|\zeta_{i}\right|^{\beta_{i}}} \mathrm{~d} \zeta
$$

Then one has

$$
\begin{equation*}
\sup _{a \in \mathbb{R}}(1+|a|)^{1-q+\sum_{i=1}^{q} \beta_{i}} J_{q}\left(a ; M_{1}, M_{2} ; \beta\right)<\infty \tag{73}
\end{equation*}
$$

In particular,

$$
J_{q}\left(0 ; M_{1}, M_{2} ; \beta\right)<\infty
$$

and

$$
J_{q}\left(a ; M_{1}, M_{2} ; \beta\right)=O\left(|a|^{-\left(1-q+\sum_{i=1}^{q} \beta_{i}\right)}\right) \quad \text { as } a \rightarrow \infty .
$$

Proof. Since $J_{q}\left(a ; M_{1}, M_{2} ; \beta_{1}, \cdots, \beta_{q}\right)=J_{q}\left(-a ; M_{1}, M_{2} ; \beta\right)$, we may suppose $a \geq 0$. By Lemma 8.3 ,

$$
J_{q}\left(a ; M_{1}, M_{2} ; \beta_{1}, \cdots, \beta_{q}\right)=\Gamma \int_{\mathbb{R}} \frac{|s-a|^{M_{2}}|s|^{q-1-\left(\beta_{1}+\cdots+\beta_{q}\right)}}{(1+|s-a|)^{M_{1}}} \mathrm{~d} s
$$

where

$$
\Gamma=\prod_{i=2}^{q} \int_{\mathbb{R}} \frac{\mathrm{d} t}{|t|^{\beta_{i}+\cdots+\beta_{q}-(q-i)}|1-t|^{\beta_{i-1}}} .
$$

The conditions on $\beta_{i}$ 's, $M_{1}$ and $M_{2}$ imply $J_{q}\left(a ; M_{1}, M_{2} ; \beta_{1}, \cdots, \beta_{q}\right)<\infty$ for all $a$. To obtain the sup on $a>0$, we set $v=s / a$. Then, denoting $S=\sum_{i=1}^{q} \beta_{i}$, we get

$$
\begin{equation*}
J_{q}\left(a ; M_{1}, M_{2} ; \beta\right)=C a^{q+M_{2}-S} \int_{\mathbb{R}}|v-1|^{M_{2}}(1+a|v-1|)^{-M_{1}}|v|^{-S+(q-1)} \mathrm{d} v \tag{74}
\end{equation*}
$$

where $C$ is a positive constant. We separate the integration domain in two. Suppose first that $|v-1| \leq a^{-1}$. Then in this case we have $(1+a|v-1|)^{-M_{1}} \leq 1$. Since $|v|$ is bounded on the interval $|v-1|<a^{-1}$ for $a$ large then as $a \rightarrow \infty$,

$$
\int_{|v-1| \leq a^{-1}}|v-1|^{M_{2}}(1+a|v-1|)^{-M_{1}}|v|^{-S+(q-1)} \mathrm{d} v=O\left(\int_{|v-1| \leq a^{-1}}|v-1|^{M_{2}} \mathrm{~d} v\right)=O\left(a^{-1-M_{2}}\right) .
$$

Now suppose that $\left|v-1>a^{-1}\right|$. Then $(1+a|v-1|)^{-M_{1}} \leq(a|v-1|)^{-M_{1}}$, and

$$
\begin{aligned}
I= & \int_{|v-1|>a^{-1}}|v-1|^{M_{2}}(1+a|v-1|)^{-M_{1}}|v|^{-S+(q-1)} \mathrm{d} v \\
\leq & a^{-M_{1}} \int_{|v-1|>a^{-1}}|v-1|^{M_{2}-M_{1}}|v|^{-S+(q-1)} \mathrm{d} v \\
= & a^{-M_{1}}\left(\int_{|v| \geq 2}|v-1|^{M_{2}-M_{1}}|v|^{-S+(q-1)} \mathrm{d} v+\int_{1 / 2 \leq|v| \leq 2,|v-1|>a^{-1}}|v-1|^{M_{2}-M_{1}}|v|^{-S+(q-1)} \mathrm{d} v\right) \\
& +a^{-M_{1}} \int_{|v| \leq 1 / 2,|v-1|>a^{-1}}|v-1|^{M_{2}-M_{1}}|v|^{-S+(q-1)} \mathrm{d} v .
\end{aligned}
$$

The first integral concentrates around $v=\infty$, the second around $v=1$ and the third around $v=0$. The first integral is bounded, the second is

$$
O\left(\int_{|v-1|>a^{-1}}|v-1|^{M_{2}-M_{1}} \mathrm{~d} v\right)=O\left(a^{M_{1}-M_{2}-1}\right), \quad \text { as } a \rightarrow \infty,
$$

and the third is bounded. Therefore we get

$$
I=O\left(a^{-M_{1}}\right)+O\left(a^{-M_{2}-1}\right),
$$

since $M_{2}-M_{1}<-1$. Thus (74) gives

$$
J_{q}\left(a ; M_{1}, M_{2} ; \beta\right)=O\left(a^{-1+q-S}\right) \quad \text { as } a \rightarrow \infty
$$

yielding the bound (73).
